# Finance Manager, Europe

## Overview

- Manage and comply with in-country government reporting requirements and tax filings.
- Key liaison for external audit process & external tax advisory.
- Provide financial insights to support strategic decision making.
- Develop a set of pan Europe finance related policies and procedures.
- Establish and maintain strong internal controls for financial processes.
- Recommend and implement cross-country financial management processes for Prosci Europe.
- Lead and develop the European finance team.



- Ensure effective communication and collaboration within the finance function and with other departments.
- Work with the European Financial Controller and Centre of Acceleration to ensure financial activities in Europe align with the overall corporate financial strategy.

- Excellent verbal and written communication skills, able to present financial concepts in easily understood language to management and staff at all levels of the organisation.
